Applicants may request up to the max amount but smaller requests are more likely to be awarded the total amount of \$40,000 was awarded in 2013 with the same or higher being expected to be awarded for 2014.

General Eligibility Requirements

Student applicants for university research grants must have graduate student status during the term of the grant to be considered for funding. At the time of application, student applicants as well as all faculty co-investigators or applicants must be a Member of the ISSN. Grants are open only to members of the ISSN. Applicants are not eligible to win more than one grant in any given year.

All grant applications must be submitted by **January 1**st of 2015 and awards will be provided no sooner than February 1st. All grant applicants will be required to sign a grant agreement and consent form prior to review and approval of their applications.

Complete submissions must be sent to ISSN.sports.nutrition@gmail.com as partial/incomplete submissions will be immediately rejected. Additional instructions, requirements, and guidelines are provided below.

Current Grant Programs and Requirements

All funding is provided by MusclePharm Corporation and will be dispersed through the ISSN if the application is approved.

University Grants

University Grants can be awarded to graduate students, faculty members, or University Strength Coaches, Athletic Trainers or University Sport Nutritionist/Dietitians. Research grants awarded to student applicants under this program require that a faculty co-investigator be identified. All faculty co-investigators must also be a member of the ISSN.

Private Grants

Private grants can be awarded to certified personal trainers, strength coaches, private athletic trainers or sports nutritionists or to private research institutions.

General grant information and requirements

 All grant applicants must be a member of the ISSN. The lead grant recipient will agree to take and pass the CISSN exam.





- If the exam is taken in the first year after being awarded the grant they will be eligible to take the exam at discount of \$99.00.
- o All individuals on the grant will also have the opportunity to take the exam for \$99.
- If the exam is taken after the first year the lead grant recipient and other members on the grant can take the exam at the regular price of \$599.00
- All grants require the use of one or more MusclePharm product.

- MP products and placebos will be provided at no charge to the grantees in addition to the
 grant award amount. MP will also provide Certificates of Analysis for the product/placebo
 in line with GMP guidelines. Any other research supplies or products being tested must
 be paid for using the grant award or other funds.
- All grantees are required to attend the National ISSN conference for the year the grant was awarded and/or the following year and present a poster on the findings.
 - The cost of conference registration for the presenter/grantee will be waived and they will receive a free one year membership to the ISSN after their current year membership expires.
- All grants will require study participants to sign an informed consent document. Any study
 that incorporates human intervention will undergo University or private Institutional Review
 or IRB review by MusclePharm's internal IRB and Approval ensuring that the Informed
 Consent covers the required areas of concern
 (http://www.hhs.gov/ohrp/policy/consentckls.html). If the study is not going through an
 IRB, both the ISSN and MusclePharm must approve the consent form.
- All grant applications will be approved and reviewed by both MP and ISSN for quality, methodology, staff ability, practicality, and budget.
- All publications will acknowledge MusclePharm Corporation as the funding source and ISSN as the administrator of the Unrestricted Educational Grant.

- 14. IRB and Consent Form
 - a. Identify how and when the study will be approved by an IRB
 - Approval is not necessary at the time of application, but must be provided before any awarded funds are disbursed. No money will be provided by the ISSN unless proof of IRB approval is provided.
 - ii. University applicants are required to gain IRB approval from their institution IRB
 - iii. Private facilities can gain IRB approval from a local university or may submit to the MusclePharm IRB.
